We provide formal employment in Mexico to over 250,000 people a year. Registering them from the 1st day in IMSS and INFONAVIT with their actual salary and we always issue their receipt for the total wage, stamped before the SAT.



Free training for all assigned Employees. Over 200,000 people have been trained through MyPath & powerYOU where we offer more than 2,000 courses (Includes training in computer programs, communication, leadership and other professional and technical skills).



We provide life insurance, medical assistance and, if necessary, we cover funeral expenses for our assigned employees (ManpowerGroup Protection).

In compliance with the Federal Law for the Prevention and Identification of Operations with Resources of Illicit Origin (LFPIORPI), ManpowerGroup has launched a group of actions with the aim of fulfilling the obligations established in said legal order and in accordance with the interpretation issued by the Financial Intelligence Unit (FIU) in October 2016.
